It was created to provide financial assistance for conflict resolution initiatives with national and international impact and to share its dispute resolution experience and expertise for the benefit of the public interest.

To date, the JAMS Foundation has received more than \$14 million in donations and has distributed more than \$11 million in grants and fellowships to more than 150 nonprofit organizations. This funding has been made possible entirely by JAMS neutrals, employees and the company itself, as JAMS recognized early on that external funding could compromise neutrality. Today, more than 300 principal benefactors pledge at least 1% of their JAMS income to support the Foundation's work.
