JAMS Expands Footprint In Atlanta With Modern Office

Law360 (November 24, 2025, 4:47 PM EST) -- Alternative dispute resolution provider JAMS has relocated its Atlanta office to a larger 9,963-square-foot space in the city after seeing more in-person proceedings than virtual ones this year.

Stacey Harrison, vice president of operations for the Atlanta office, told Law360 Pulse Monday that the new location at Promenade Tower is equipped with the latest technology to support arbitrations and mediations. The previous office space was 8,329 square feet.

"It's important that we're able to see every case that comes in to us, and so we have more comfort for the people," Harrison said. "You can have two arbitrations going on at one time, all with mediations or other ADR processes going on."

The space at 1230 Peachtree Street NE, Suite 2950, has 16 conference rooms, including client arbitration lounges, two arbitration rooms, mediation rooms, an executive boardroom and attorney offices.

"We have advanced technology," Harrison said. "Fifty percent of our conference rooms have video capable of using Zoom or MS Teams and 75 to 90-inch screens for optimal viewing capability and microphones to enhance the sound. The arbitration rooms actually have four cameras in them to obtain close facial expressions of witnesses anywhere in the room."

The move took place on Nov. 17, but JAMS began planning the move about nine months ago and construction on refurbishing the space started about six months ago, Harrison said. She said they made sure the new space was compliant with Americans with Disabilities Act requirements and met ergonomic standards.

The new office is near JAMS's old office location and boasts better views and a newer, upgraded building, Harrison said.

"As we were growing and developing, it was time for something new," Harrison said. "It was time for a change. We have great views. It's modern. Now it reflects every other JAMS office in the country."

The Atlanta office has 25 neutrals, according to a spokesperson.

JAMS has brought on four neutrals in Atlanta over the past year.

Lawrence "Larry" H. Kunin, a retired Morris Manning & Martin LLP attorney, joined JAMS in the city after leading Morris Manning's ADR group and its technology litigation practice.

Timothy C. Batten joined the panel after retiring from serving as a judge for the Northern District of Georgia.

William H. Farmer joined after serving as a partner at Farmer Purcell White & Lassiter PLLC. His experience includes handling more than 70 jury trials over his decades-long career as a litigator.

J. Clay Fuller, a retired Northern District of Georgia magistrate judge, joined with experience handling hundreds of mediations.
