Biography

In addition to his work as an arbitrator and mediator, **Chris M. Mr. Kwok was born in China and raised in Queens. He joined JAMS after a 15-year career at the New York District Office of the U.S. Equal Employment Opportunity Commission (EEOC). During his tenure at the EEOC, Mr. Kwok also served for four years as supervisory ADR coordinator, where in addition to his own mediation work, he oversaw employment law mediations across EEOC offices within the New York District Office region. He proudly helped create the Asian American Pacific Islander Network, where he served as its founding Chair. This organization served as the national Asian American employee resource group for the EEOC. He also served as the EEOC NYDO representative to the White House Initiative on Asian Americans Pacific Islanders.
